**A RESOLUTION OF THE MAYOR AND
COUNCIL OF THE TOWN OF PARADISE
VALLEY, MARICOPA COUNTY, ARIZONA,
DECLARING AND ADOPTING THE RESULTS
OF THE GENERAL ELECTION HELD FOR
TOWN COUNCIL ON MAY 18, 2010**

WHEREAS, the Town of Paradise Valley, Maricopa County, Arizona, held a General Election on the 18th day of May, 2010 for the non-partisan at-large election of three Council Members; and,

WHEREAS, in accordance with Resolution Number 1200 the election was conducted as a consolidated polling place election with Maricopa County; and,

WHEREAS, the election returns have been presented to, and have been canvassed by, the Town Council of the Town of Paradise Valley.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Town Council of the Town of Paradise Valley, Maricopa County, Arizona, as follows:

SECTION 1. That the total number of valid ballots cast at said General Election, as shown by the poll lists, was 4,818;

SECTION 2. That the total number of rejected ballots was 56;






