RESOLUTION NUMBER 1251

A RESOLUTION OF THE MAYOR AND COUNCIL OF THE TOWN OF PARADISE VALLEY, MARICOPA COUNTY, ARIZONA, DECLARING AND ADOPTING THE RESULTS OF THE PRIMARY ELECTION HELD FOR MAYOR AND TOWN COUNCIL ON MARCH 13, 2012

WHEREAS, the Town of Paradise Valley, Maricopa County, Arizona, held a Primary Election on the 13th day of March, 2012 for the non-partisan at-large election of the mayor and three Council Members; for Proposition 438, regarding the ratification of the 2012 General Plan; and Question 1, regarding granting a utility franchise to Arizona Public Service Company; and,

WHEREAS, in accordance with Resolution Number 1060 the election was conducted by “all-mail ballot”; and,

WHEREAS, the election returns have been presented to, and have been canvassed by, the Town Council of the Town of Paradise Valley.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Town Council of the Town of Paradise Valley, Maricopa County, Arizona, as follows:

SECTION 1. That the total number of valid ballots cast at said primary election, as shown by the poll lists, was 4,523;

SECTION 2. That the total number of rejected ballots was 94;

SECTION 3. That the total number of votes cast for each candidate for the Office of Mayor were as follows:


