

RESOLUTION NUMBER 1317

**A RESOLUTION OF THE MAYOR AND COUNCIL
OF THE TOWN OF PARADISE VALLEY,
MARICOPA COUNTY, ARIZONA, DECLARING
AND ADOPTING THE RESULTS OF THE PRIMARY
ELECTION HELD FOR MAYOR AND TOWN
COUNCIL ON AUGUST 26, 2014**

WHEREAS, the Town of Paradise Valley, Maricopa County, Arizona, held a Primary Election on the 26th day of August, 2014 for the non-partisan at-large election of the mayor, three four-year Council terms, two two-year Council terms, and Question 1, regarding granting a utility franchise to Southwest Gas Corporation; and,

WHEREAS, in accordance with Section 2-3-6 of the Town Code the election was conducted by “all-mail ballot”; and,

WHEREAS, the Town’s local offices appeared on a consolidated Maricopa County partisan Primary Election ballot in accordance with Arizona law; and,

WHEREAS, the election returns have been presented to, and have been canvassed by, the Town Council of the Town of Paradise Valley.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Town Council of the Town of Paradise Valley, Maricopa County, Arizona, as follows:

SECTION 1. That the total number of valid ballots cast at said primary election, as shown by the poll lists, was 3,927;

SECTION 2. That the total number of rejected ballots was 54 (28 no signatures, 17 returned late, 9 bad signatures);

SECTION 3. That the total number of votes cast for each candidate for the Office of Mayor were as follows:


