**A RESOLUTION OF THE MAYOR AND COUNCIL  
OF THE TOWN OF PARADISE VALLEY,  
MARICOPA COUNTY, ARIZONA, DECLARING  
AND ADOPTING THE RESULTS OF THE PRIMARY  
ELECTION HELD FOR MAYOR AND TOWN  
COUNCIL ON AUGUST 28, 2018**

WHEREAS, the Town of Paradise Valley, Maricopa County, Arizona, held a Primary Election on the 28<sup>th</sup> day of August, 2018 for the non-partisan at-large election of the Mayor, three Council Members; and,

WHEREAS, pursuant to A.R.S. § 16-204, the Town's election was consolidated with the Maricopa County Primary Election ballot; and,

WHEREAS, the election returns have been presented to, and have been canvassed by, the Town Council of the Town of Paradise Valley.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Town Council of the Town of Paradise Valley, Maricopa County, Arizona, as follows:

SECTION 1. That the total number of valid ballots cast at said primary election, as shown by the poll lists, was 4,394;

SECTION 2. That the total number of rejected ballots equaled 31 (6 no signatures, 22 returned late, 3 bad signatures);

SECTION 3. That the total number of votes cast for each candidate for the Office of Mayor were as follows:


